LOMPOC HOSPITAL DISTRICT SPECIAL TAX MEASURE					
<p>A Shall the Lompoc Hospital District be authorized to fix a tax and the County of Santa Barbara be authorized to collect it, in the same manner as the county ad valorem property taxes, to provide funds for maintenance and operation of the Convalescent Care Center in the District not to exceed \$37.00 per year, per assessor's parcel located in the District, to continue each year until terminated or reduced by a resolution of the Lompoc Hospital District Board of Directors. A termination or reduction in one year shall not effect the power of the Board to impose the full amount of the tax in any succeeding year. 
